- 1. Call to Order: The meeting was called to order by Chairperson Bill Robe at 11:04 a.m.
- 2. **Public Forum:** Chairperson Robe called for public comment. Hannah Dineley announced that CSUCI received a grant for fruit trees, the fruit will be donated to the Dolphin Pantry.

## 3. Information and Action Items:

- **a.** Approval of minutes from February 28th, 2019 (Bill Robe): David Press motion to approve, Hannah Dineley seconded the motion, and passed unanimously.
- b. Director's Report (John Lazarus):
- c. Executive Summary (John Lazarus) and Presentation of 19/20 Budget (John Lazarus and Stephanie Bracamontes)
  - 1. Review of Revenues and Expenses for: Corporate, Dining, Auxiliary Services, and Reimbursed Activities.
  - 2. Base Management decrease by \$153k due to elimination of salaries and benefits.
  - 3. Management- Eliminate ED salary \$9K, Assoc. Director \$93k, Reclassify Support position to Management\$ 53K
  - 4. Support Staff-Eliminate 1 support staff \$45K
  - 5. Benefits -Reduction due to elimination of Management salaries \$50K
  - 6. Food Sales reduced by \$88K to reflect a 3 year avg. growth rate of 5%
  - 7. Residential Flex Cash Revenue increased by \$130K based on census information, also includes a reduction of 40 meal plans projected in the spring
  - 8. Meal Plan revenue decreased by \$78k based on census information, also includes a reduction of 40 meal plans projected in the spring
  - 9. Management Salaries: Executive Chef increase \$9k, Retail Manager increase \$13k, Eliminate 2 Managers \$93K
  - 10. Management Fee decreased by \$147K due to eliminated positions in UGC Corp
  - 11. Management Fee decreased by \$ 6kdue to eliminated positions in UGC Corp
  - 12. Lease payments -increased by \$17k due to TC Cams reconciliation for 16-17
  - 13. Town Center Market and Pizza 3.14 continue to be unprofitable

- 14. Freudian Sip (at library) Conversion to Starbucks (Proudly Serving) should see a \$49K increase with 3yr projection
- 15. Bookstore selling less books Renegotiated operating agreement with Follett
- d. Discussion of Budget (Bill Robe)

Business expected to trend upwards since student enrollment is increasing. Further research needed on CAM fees.
